NOTICE: NOMINATION OF A CANDIDATE FOR THE BOARD OF TRUSTEES ELECTION – CONTINUATION/RETIRED/WIDOWED MEMBER REPRESENTATIVE

The time has come to elect new trustees to the Bestmed Medical Scheme Board of Trustees (BoT), as the term of office of some of the current member-elected trustees will come to an end at the 2026 Annual General Meeting (AGM). As a principal member who has either continued your membership after retiring from a participating employer, or was a dependant of a deceased principal member and chose to continue the membership as a principal member (i.e. in your own name), you are invited to nominate one candidate as Continuation/Retired/Widowed member representative to serve on the Board of Trustees.

Composition of the Board

In terms of the stipulations of Rule 18.1 of the registered Bestmed Rules, the affairs of the Scheme shall be governed by a Board of Trustees, consisting of no more than 10 persons, who are fit and proper to manage the business contemplated by the Scheme. Half of these Board members must be elected by members (i.e. principal members) of Bestmed.

To maintain the 50% representation, members are invited to nominate a person(s) to stand for election to fill a Continuation/Retired/Widowed member representative vacancy, which will be available at the end of the 2026 AGM. The vacancy exists because of the expiry of the term of office of the current incumbent, who is no longer eligible for nomination and re-election due to having served the maximum terms of office stipulated in the Bestmed Rules.

The registered Bestmed Rules further provide for a four-year term of office for Board of Trustees members.

Nomination process

When nominating a candidate as a Continuation/Retired/Widowed member representative, please bear the following in mind:

- (a) The candidate nominated as a Continuation/Retired/Widowed member representative must be a Bestmed principal member, who has retained their membership on retiring from a participating employer or was a dependant of a principal member who passed away, but has opted to continue with the membership as principal member, and who is and remains in good standing with the Scheme. The Scheme considers 'members in good standing' to be those whose contributions are up to date.
- (b) As stipulated in Rules 18.3.1 and 18.3.2, a principal member registered as a Continuation/Retired/Widowed member must nominate a candidate, and such nomination must be seconded by another Bestmed principal member, who is registered as a Continuation/Retired/Widowed member. Alternatively, a candidate may be nominated by two Bestmed principal members, who are registered in a Continuation/Retired/Widowed member capacity, in which case the two individual nominators will be treated as a nominator and seconder. Both the nominator and seconder must be in

good standing with Bestmed. Consequently, self-nominations or nominations made and/or seconded by dependants will be declared invalid.

- (c) The nominee must accept the nomination in writing by completing the enclosed nomination form. Otherwise, the nomination will be regarded as invalid.
- (d) Acceptance of the nomination by the person nominated will signify that they agree to be bound by the registered Bestmed Rules, as well as the Trustee Guidelines. Both these documents can be made available on request.
- (e) The Board requires expertise in the fields of actuarial science, business management, healthcare, human resources, information technology, investment management, law, marketing and/or risk management. It would be to the benefit of the Scheme and its members to nominate a candidate who has skills in one or more of these areas.
- (f) Nominations of members who are not registered as principal members in a Continuation/Retired/Widowed capacity will be declared invalid.
- (h) In line with Rule 18.1.3 of the registered Bestmed Rules, the eligibility of the nominated candidate to stand for elections will be subject to a vetting process administered by an Independent Electoral Body (IEB) appointed by Bestmed. In this regard, all nominees will be evaluated against the provisions of the Medical Schemes Act 131 of 1998, as amended, and the registered Bestmed Rules eligibility criteria.

An election will be held among all the members of the Scheme if two or more nominations are received for the vacancy.

Please note: In accordance with Bestmed Rules, the nomination period will commence earlier and will be for the duration of only one month instead of three months.

Appointed Independent Electoral Body (IEB)

Following the procurement process, PricewaterhouseCoopers Incorporated (PwC) has been appointed as the IEB in respect of the following electoral processes and voting activities:

- the call for trustee nominations
- receiving and vetting of nominations received from members
- overseeing the election processes

The duly completed enclosed nomination form, together with the required documents indicated in the paragraphs that follow, must reach PwC, the appointed IEB, during the nomination period from **Friday, 1 August 2025 until 23:59 on Sunday, 31 August 2025** via any of the following channels:

A copy of the nomination form can also be downloaded from the Scheme’s website at www.bestmed.co.za by clicking on the menu icon (top right) > ABOUT US > Governance > select BOT ELECTION and click on the relevant membership category to download the letters and forms.

All nominations must be submitted using the prescribed nomination forms, and all requirements contained in the form must be fulfilled to avoid the nomination being disqualified. The nomination form must be completed fully and properly to ensure that the nomination can be considered. Failure to complete the nomination form as prescribed, or to return it before the set date and time, or failure to provide any required document/s, may result in the nomination being disqualified.

For the vetting, the nominee is required to submit the following documents together with the completed and signed nomination form:

- A detailed curriculum vitae
- A certified copy of the nominee’s identity document
- A certified copy of the nominee’s highest academic qualification
- Proof of the nominee’s SARS personal tax clearance or a PIN to access the nominee’s tax clearance certificate on the SARS eFiling system
- A recent high-resolution photo of the nominee, and
- An abridged curriculum vitae of no more than 100 words. The abridged curriculum vitae and a photo of successful nominations will be published in a candidate booklet, which will be made available to all principal members of Bestmed.

No nomination forms may be delivered to the Bestmed Medical Scheme offices. Any nomination forms submitted either in person or to the details not indicated above will automatically be considered invalid and, therefore, disqualified.

All election-related queries must be directed to the IEB via telephone at 012 429 0505 or email at za_bestmedelection2026@pwc.com (please note the underscore “_” in the email address). The IEB will be the only party to respond to queries related to the electoral processes.

The abovementioned IEB telephonic and email contact details will only be operational between 08:00 and 16:30, Mondays to Fridays, excluding weekends and public holidays. Once the election has been completed, this number and email address will be closed.
